

## RULES FOR PARTICIPATION BLACK+DECKER REDEMPTION

The Battery Redemption promotion (hereafter referred to as the "Promotion") is promoted by BLACK+DECKER Nordics, a division of Stanley Black & Decker whose registered address is Flöjelbergsgatan 1c, Box 94, SE-431 35 Mölndal, Sweden (hereafter referred to as the "Promoter").

### Eligibility

The Promotion is applicable to Nordic residents only, excluding employees and their immediate families (defined as parents, siblings, children & spouse regardless of where they live) of the Promoter, its affiliated companies, their agents or anyone professionally connected with the Promotion.

In order to qualify for the Promotion, participants must:

### Terms & Conditions

1. The Battery Redemption promotion (hereafter referred to as the "Promotion") is promoted by BLACK+DECKER Nordics, a division of Stanley Black & Decker whose registered address is Flöjelbergsgatan 1c, Box 94, SE-431 35 Mölndal, Sweden (the "Promoter").

#### 1. Eligibility

The Promotion is applicable to Sweden residents of full legal age. Employees and their immediate families (defined as parents, siblings, children & spouse regardless of where they live) of the Promoter, its affiliated companies, their agents or anyone professionally connected with the Promotion are excluded. Only one claim per purchase and per person and household will be accepted. ONLY the first valid product purchased will be eligible for redemption.

#### 2. How to participate

In order to qualify for the Promotion, Within Promotion Period purchase a cordless BLACK+DECKER POWER CONNECT tool (new, not second hand) at customer:

Claims for products purchased before or after this promotional period will be deemed invalid. After purchase the tool must be registered on local MyBLACK+DECKER to redeem the claim.

### 3. Specific Seller Exclusions

Products purchased from outside Sweden are not eligible for this promotion. Products purchased from eBay or other online shops outside Sweden, whether listed as new or otherwise, will not be eligible for this Promotion. Please check with your retailer for further information to avoid disappointment.

### 4. Eligible sellers:

Products must be purchased within one of the retailers in Sweden.

### 5. Redemption product

BLACK+DECKER POWER CONNECT tools.

No cash alternative is available for this Promotion. The redemption product is not transferable, and can't be refunded or exchanged

### 6. Claim Process

To qualify for the Promotion participants must complete the online registration form via MyBLACK+DECKER available at <https://www.blackanddecker.dk/da-dk/my-black-and-decker/>

and upload a copy of their full purchase receipt. Participants must ensure that their purchase receipt includes both the date of purchase and model purchased.

8. The Promoter will not process a claim if participant cannot provide an image of the purchase receipt.

11. Upon submission of the claim form participants will be sent an email to confirm participation to the promotion.

Where the Promoter is unable to meet this deadline participants will be informed of the timeframe within which the redeemed product will be expected to be received. If the redeemed product has not been received within 30 days from the date of the confirmation email, participants are invited to contact the Promoter, using the contact details above, no later than 35 days after the claim submission. Regrettably claims pursued after this time will not be accepted.

The Promoter reserves the right to verify the eligibility of all claims to protect itself against fraudulent, invalid or repetitive claims including, without limitation, to require the participant to prove that they did not return the product within the period of 31 days from the date of delivery.

14. Claims for returned products, bad faith or fraudulent entries will be invalidated.

The Promoter will not be held responsible or liable for any technical, hardware, software, server, website, or other failures or damage of any kind to the extent that this prevents the participant from or otherwise obstructs the participant to enter in the Promotion.
